As a condition of using our services for your pets, the following Waiver & Assumption to Hold Harmless must be signed:

By choosing to utilize the services, participate in activities, groom or board my pet(s) at Companion Club Doggie Daycare, I agree to the following:

- I agree to pay the rates that are in effect at the time my pet is at Companion Club Doggie Daycare. I am aware that extra charges may be incurred and I agree to pay them at the time of pick-up. Examples include, but are not limited to: Daycare, boarding, grooming.
- I understand that there is a minimum \$200.00 boarding deposit for holiday boarding and is non-refundable if I cancel my boarding reservation. I also understand that the boarding deposit is to be made the day of the reservation.
- If my dog participates in daycare, I understand that an interactive play setting is not without some risk of injury, that despite all the dogs appearing healthy and being handled with the greatest amount of care and foresight, dogs are not always predictable in the unexpected may occur. I recognize that the benefits of an interactive playgroup are valuable to my dog, and accept the potential risks. I further agree to pay veterinary/medical expenses incurred as a result of injury to or caused by my dog.
- If my pet appears to be ill, I authorize Companion Club Doggie Daycare to engage the services of a veterinarian at my expense, to give other requisite attention, and to make whatever decisions are required for my pet's veterinary treatment. I agree to pay all veterinary charges incurred by my pet while in the care of Companion Club Doggie Daycare. I will not hold Companion Club Doggie Daycare liable for failure to seek veterinary attention or for decisions made under this contract.
- I understand that Companion Club Doggie Daycare will exercise all due diligence and care in the guardianship of my pet. I hereby waive and release Companion Club Doggie Daycare, its employees, owners and agents from any and all liability of any nature, for injury or damage, including that which may result from the action of any dog including my own, and I expressly assume the risk of such damage or injury while my dog participates in or attends any function of Companion Club Doggie Daycare, while on the grounds or the surrounding area thereto.
- I understand that I am required to provide Companion Club Doggie Daycare documented vaccination records and to keep the vaccination up-to-date for the duration of my dog participation at Companion Club Doggie Daycare

Rules and Requirements

To ensure the health and safety of your pet and of our other guests, we require that all of our clients comply with the following rules and regulations.

1. All dogs must be at least 4 months of age or older. All dogs over the age of 7 months must be spayed or neutered. Puppies and shelter dogs must be in the home for 1 month prior to coming to daycare.
2. If dogs prove to be markers or habitual wetters; belly bands will be put on the dog for training purposes.
3. All dogs must have up-to-date vaccinations. Owners must submit written proof that their dogs have current DHLPP (distemper), rabies and bordetella (kennel cough) vaccinations.
4. All dogs must be in good health. Owners will certify that their dog(s) are in good health and have not been ill with a communicable condition in the last 30 days. Upon admission, all dogs must be free of any condition that could potentially jeopardize other guests, including fleas or ticks. Dogs that have been ill with a communicable condition in the last 30 days will require veterinarian certification of health to be admitted or readmitted.
5. Owners will need to certify that their dog(s) have not harmed or shown aggression or threatening behavior towards any person or other dog(s).
6. All dogs must have a complete, up-to-date and approved application on file prior to attending daycare.
7. Please, do not bring personal items like bones or toys for daycare. We have food/water bowls, measuring cups, treats and toys.
8. If a pet that is presented for daycare or overnights is found to have fleas and/or ticks, it will be bathed at the owner's expense.
9. Owners must bring any dog food that is to be given to their dog(s).

Certificate of Health and Temperament

Further, I agree to assume full financial responsibility for any and all expenses incurred.
8. I understand that Companion Club Doggie Daycare is a cage-free facility. I accept the risks involved and agree that Companion Club Doggie Daycare is not liable for any inquiries or illnesses resulting during my dog's attendance.
9. I hereby declare to Companion Club Doggie Daycare that I am legal owner of my dog; that my dog has not been exposed to distemper, rabies or parvo within the past (30) thirty days; that my dog(s) has been inoculated as indicated by records presented; that my dog(s) is currently and properly licensed; and that I (the owner) have read this agreement in its entirety.
